



About this report












Q8 - My onboarding experience with E&P Consulting was positive




Q11 - I get sufficient support from my E&P Consulting line manager at my monthly one-toone meetings




Q12 - My monthly one-to-one meetings with my E&P Consulting line manager are happening at the right frequency






Q15 - If I have any concerns with a client that I am placed with, I understand the path of escalation in E&P Consulting to address this




Q16 - If I have any concerns with E&P Consulting, I understand the path of escalation in E&P Consulting to address this




Q17 - I feel E&P Consulting supports me with navigating the environment of being a contractor consultant




Q18 - As an organisation, E&P Consulting communicates their vision and ambitions with consultants













Q22 - I am satisfied with my work environment






